

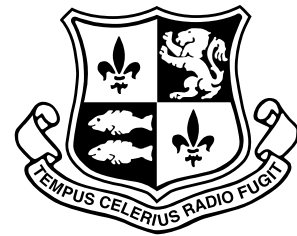
## **Abbotsleigh Boarder Parents' Association Daisy Club rules of operation 2018**

**ABN 78731787623**

1. Pregnancy tested in calf (PTIC) cows on 2nd or 3rd calf, steers or sheep to be purchased from landowners only with Daisy Club funds.
2. PTIC cows, steers or sheep can be donated by landowners or a third party.
3. Price for purchase of livestock approved by Daisy Club Committee.
4. All stock to be ear tagged with Abbotsleigh supplied ear tags including offspring at birth to show purchased/donated stock.
5. All agistment, animal health and bull costs to be borne by the landowner.
6. Larger costs such as veterinary expenses may be deducted from the sale price, but landowner must notify Daisy Club of costs incurred.
7. Proceeds are to be sent directly to the Daisy Club account and are less all selling costs such as cartage, yard dues and commission. This is at the discretion of the landowner as selling costs may be donated by the landowner. If sold through Landmark, proceeds can be sent directly to Daisy Club and there will be no commission.

*Please note: The Daisy Club is **not** GST registered*

8. Profits from the Daisy Club will be given to the Abbotsleigh Foundation in accordance with the motion passed at the general meeting of ABPA in 2009 which reads: 'All Daisy Club profits, above and beyond working capital should flow to the Foundation, but the Daisy Club, through discussion and agreement with the ABPA, reserves discretionary power to earmark this money for specific projects.'
9. Committee members will be in contact with landowners at least twice a year to discuss livestock and sales.
10. Landowners who volunteer to agist livestock will sign a simple contract (attached) and return to the Daisy Club Secretary.
11. Those volunteers who sell stock to the Daisy Club will be issued with a tax invoice upon receipt of a signed contract.
12. Any disputes are to be referred directly to the Daisy Club Committee.

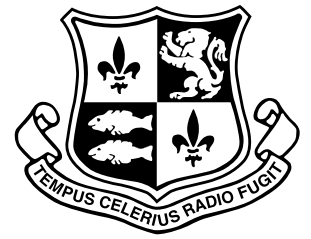

### **Livestock**

#### **Sale through Landmark**
